Residency.

The Moores Rowland team has a great deal of experience advising on the complex issues surrounding relocation and immigration to Monaco including all visa and residence card submissions.

The team is used to working very closely with the relevant government departments, Monegasque institutions, banks and contractors to make the process as smooth and as painless as possible.

The requirements for settling in Monaco vary depending on the nationality of the individual but in all cases applicants for a permanent residency card (Carte de Séjour) must be at least 16 years of age and demonstrate proof of accommodation and financial self-sufficiency.

Proof of accommodation can include one of the following:

- Acquiring local real estate;
- Renting/leasing an apartment adapted to the individual's needs for a minimum of one year;

 Being the beneficial owner of a company that holds corporate real estate in Monaco; 4.

 Providing a certificate of free accommodation from a close relative with whom the applicant plans to live with in Monaco.

Demonstrating financial self-sufficiency can include one of the following:

- Depositing at least €500,000 into a local bank account in the applicant's name; Showing the applicant is (or will be) employed by a company based in Monaco;
- Forming a new company in Monaco;
 Show proof of being self-employed, or being a manager or director of a company in Monaco or the surrounding area;
 Providing an attestation of financial
- support from a close relative with whom the applicant plans to live with in Monaco.
